

**RAISE YOUR HANDS**  
**ENTERTAINMENT CONTRACT RIDER**

This Entertainment Rider ("Rider") is hereby attached to and made part of the contract dated \_\_\_\_\_ ("Contract") between **Raise Your Hands** (herein referred to as "BAND") and \_\_\_\_\_ (herein referred to as "PURCHASER").

**LOAD-IN AND STAGE ACCESS**

1. Written notice of conditions that may impede load-in/access (e.g., flights of stairs, elevators, narrow entrance ways or passages, long distance between parking and venue, etc.)
2. A secured parking area for BAND's vehicle. The area should be easily accessible to the venue's load-in doors, dressing rooms, and stage. If the BAND is providing sound and lighting, one additional space will be required for Sound & Lighting.
3. The stage area must be accessible at least 4 hours before the performance. Soundcheck should begin no later than two (2) hours before the performance.
4. A designated space for empty equipment cases must be provided. This may be the same as the Green Room if appropriately sized.

**GREEN ROOM & AMENITIES**

1. A designated private area must be provided for the BAND to change and prepare before the performance. It must be clean, dry, and at an appropriate temperature.
2. The Green Room must have at least 2 working electrical sockets.
3. The Green Room must be stocked with a minimum of 2 cases of bottled water, one of which should be left on stage during the performance.
4. If the band is expected to be onsite for more than 3 hours, 1 meal for 6 people must be provided 2 hours prior to the performance. This will be coordinated and arranged between The PURCHASER and The BAND.

**SOUND, LIGHTING AND STAGE**

1. The stage size must be a minimum of 16" x 20' W.
2. Minimum Power requirements:
  - o 1-20 amp Dedicated Circuit - if band is NOT responsible for providing sound and lights
  - o 6-20 amp Dedicated Circuits - if band IS responsible for providing sound
3. Detailed sound requirements and input lists have been included as separate attachments.

**TRAVEL AND ACCOMMODATION**

1. If overnight lodging is required and arranged by the PURCHASER, it must be of hotel quality with a 3-star rating or above.
2. Three (3) double rooms must be provided.
3. The hotel must be within a 20-minute driving range of the performance venue.

**TERMINATION AND CANCELLATION**

1. Notification of cancellation of services must be made thirty (30) days prior to the performance date.
2. Cancellation fee equivalent to 20% of the agreed-upon performance fee must be paid no later than 30 days from when the performance would have occurred.
3. In the case of an act of God, the PURCHASER is entitled to cancel the Artist's performance without penalty up to 24 hours before the scheduled performance. A performance canceled under 24 hours of the Performance will be subject to total agreed compensation amount in full.
